## **Natura Gardens Consent, Release and Liability Waiver**

**Please read this entire Acknowledgment and Assumption of Risks and Release and Indemnity Agreement (hereafter Document) carefully before signing.**

**Release and Waiver.** Participant does hereby release and forever discharge and hold harmless Natura Gardens LLC. from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participant's activities with Natura Gardens LLC. Participant understands that this Release discharges Natura Gardens LLC from any liability or claim that the Participant may have against Natura Gardens LLC with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Participant's activities with Natura Gardens LLC, whether caused by the negligence of Natura Gardens LLC. or its owners, employees, agents or otherwise. Participant also understands that Natura Gardens LLC. does not assume any responsibility for or obligation to provide financial assistance or other assistance, including, but not limited to medical, health, or disability insurance in the event of injury or illness.

**Medical Treatment.** Participant does hereby release and forever discharge Natura Gardens LLC from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Participant's activities with Natura Gardens LLC.

**Assumption of Risk.** Participant hereby expressly and specifically assumes the risk of injury or harm in the activities and releases Natura Gardens LLC. from all liability for injury, illness, death, or property damage resulting from the activities.

**Insurance.** The Participant understands that Natura Gardens LLC. does not carry or maintain health, medical, or disability insurance coverage for any Participant. Each Participant is expected and encouraged to obtain his or her own medical or health insurance coverage.

The Participant agrees that, but for the enforceable nature of this document, Natura Gardens LLC. would not have permitted the activity or the Participant's participation in said activity.
